Club Industry fights through a devastating decade of political betrayal

During the past decade the Club Industry has moved from one challenge to another, with only a brief pause before being again blindsided by a State or Federal Government. And this

continues despite their constant reassurance of the industry's importance to the social fabric of our communities.

Each time the respective government promises to communicate and work closely with industry to make reforms based on evidence, and each time we become the football for political gain or promotion.

After a decade of ongoing gaming reform, increased taxation and a smoking ban, we finally believed the promises of consultation were becoming reality. We even enjoyed a sigh of relief before the 2010 Federal Election when the Opposition and Government pledged their support - in writing - for the industry, with no gaming reforms on the agenda. Gaming wasn't even on the agenda for any of the minor parties - so we thought.

Finally, the industry started to recover. For a moment clubs and boards started to regroup and show confidence to strategically plan for the future. However, this confidence was shattered by a deal to form government. Prime Minister Julia Gillard broke her first election promise, agreeing to the random conditions of an unknown Tasmanian independent. This act of betrayal destroyed the confidence and recovery of our industry.

The introduction of compulsory gaming machine precommitment and other proposed reforms sent the industry back into its shell. This decision - ill-conceived without evidence or proof to support its objectives - has driven yet another nail into the coffin of many clubs and their communities.

There has been no social impact assessment, no proven implementation strategy, no technological assessment and no cost benefit analysis. There has been a lot of posturing, politics and betrayal.

Without any legitimate study and/or research there is an almost endless list of unanswered questions, scenarios and massive challenges before this reform can be implemented.

Regardless of this, the damage is done.

Clubs and boards function without certainty and, as a result, have internalised and reviewed or cancelled strategic decisions that could have promised their recovery. These are decisions that would have produced employment and community infrastructure programs ... generated opportunities and services for already struggling communities.

Instead, these opportunities are now stopped and, in many cases, the clubs have regressed to be better prepared for the possible implementation of this tragically flawed gaming reform.

This strategy seems pointless as its instigator, Member for Denison Andrew Wilkie, himself estimates these restrictions could result in a 40% reduction in revenue. I know of no business that could survive a 40% reduction in revenue especially when the major percentage of total revenue in some clubs comes from gaming.

The added irony is that the initiatives shelved by many clubs were for alternate revenue strategies designed to reduce their reliance on gaming and to build a sustainable future.

I've heard it said many times that this proposed legislation is about responsible gambling reform. It is not. It's about abolishing poker machines and the destruction of an industry. If this was about gambling reform, there would be a comprehensive review on all forms of gambling - from horse racing to exotic betting or the unregulated online gambling sites.

Instead, every time we read a newspaper, watch television, listen to radio or attend a sporting event, we are inundated with online sports betting and agencies. BetFair has become more Australian than Vegemite. These gambling options are being celebrated and promoted, rather than questioned and investigated for their social consequences.

As a non-gambler, I don't have a problem with any of this and I believe it's an individual's right to make an educated choice. However, I do have a problem with the hypocrisy of social do-gooders in destroying an industry while and promoting another.

I also have a problem with the associated artificial "class distinction" involved in this hypocrisy. These are the people who proudly proclaim: "Oh, I'm not a club person". Yet these same "society champions" hold their charity dinners, political fundraising events and make a point of visiting "their" local clubs pre-election to canvass votes. Their children play sport sponsored by the club, or on grounds provided by the club, or read books at school provided by local clubs.

Clubs are much more than poker machine "palaces". They are meeting places and community centres. They are a place of social interaction and friendship for many elderly and incapacitated people. In most towns they are the community's evacuation centre. Clubs are the hub of the community, especially in regional centres.

Reflecting on the past decade, the major challenges that have damaged our industry have been a consequence of government legislation or political expediency. The added irony is these decisions have been made by the same political party that claims to represent the common man. Can these same "common men and women" be among the millions of club members around Australia?

I only hope the decision-makers stop for a moment of sanity and comprehend the real financial and social implications of their decisions. The NSW-Queensland Club Industry is vastly different from other states. This illconceived sweeping reform can only bring disaster. Regardless if it is a club in NSW, Queensland, Victoria or a casino Tasmania, there will be drastic consequences from these decisions.

These consequences include bankruptcy, the destruction of an industry, massive unemployment and a drastic change to the social fabric and infrastructure of our communities.

Peter leads Club Industry's argument in Canberra

The Australian Club Industry was out in force at the National Press Club Luncheon and Dinner to hear ClubsAustralia Chairman Peter Newell, OAM, debunk the myths and distortions being peddled by Tasmanian MP Andrew

Wilkie and his South Australian cohort, Senator Nick Xenophon. These men have been sharing the reins on the anti-pokies bandwagon since Mr Wilkie controversially came to power as the Member for Denison at the August 21 Federal Election. Mr Wilkie was able to extract a remarkable commitment from the Julia Gillard-led Labor Government to deal with vastly exaggerated claims about problem gambling relating to poker machines. I may be accused being biased in my opinion, but Peter Newell is one of the finest speakers that I have had the pleasure of hearing and his skills have only become more impressive during his time in the role with ClubsAustralia and as Chairman of ClubsNSW. Peter finds an extra couple of lengths in his best form when he steps up to the big challenges and the big stage. On March 23, he again articulated the Club Industry's position on the logic and legitimacy of the Gillard Government's threatened mandatory pre-commitment technology for all poker machines in venues around Australia.

The address focused on the Club Industry's opposition to mandatory pre-commitment, with Peter arguing that Mr Wilkie's \$3 billion poker machine reforms are designed to deter recreational gamblers and would not stop problem gamblers from betting.

Peter accused Mr Wilkie and his followers of ignoring the advice of some of Australia's leading gambling experts and welfare groups who have concluded that mandatory precommitment will not help problem gamblers stop betting.

"The Australian Government has seen plenty of evidence only in the last couple of months that this is a flawed proposal as far as helping problem gamblers is concerned," Peter said. "Australia's leading academic on problem gambling, Professor Alex Blaszczynski, advised a Parliamentary Committee chaired by the Member for Denison himself that pre-commitment is unlikely to have a significant impact on the majority of problem gamblers, and may even exacerbate problem gambling. Common sense tells you he's right, because problem gamblers are unlikely to set affordable limits and are likely to set high limits or none at all. And with regard to the absence of cost-benefit analysis, isn't this an amazing way to make public policy on the run - announce a wide-ranging measure impacting on millions of people, and only after that perhaps look to see what it might cost." Peter's speech to the National Press Club is published on **Pages 12 to 15**.

It was great to see Rooty Hill RSL Club's former CEO and CMAA Hall of Fame member Phil Rudder in the audience and enjoying the company and delicious luncheon. My special thanks to Nepean Zone Secretary Antoinette Sultana for her efforts in making the day so successful. The Nepean Zone AGM report and pictures are on Page 29.

The CMAA was represented at the 84th World Conference on Club Management at Orlando, Florida by former Division 1 Federal Councillor and Far North Coast Zone Secretary Gordon Rhodes. ClubsAustralia boss takes industry's fight

On Wednesday, March 23, ClubsAustralia President PETER NEWELL, OAM, returned to the National Press Club in Canberra to address the Club Industry's position on the Gillard Government's proposed mandatory pre-commitment legislation that means every gaming machine in Australia will carry the technology. The legislation is the product of Prime Minister Julia Gillard's deal with Tasmanian Independent MP Andrew Wilkie and it has massive implications for clubs ...

Abraham Lincoln once said: "I am a firm believer in the people. If given the truth, they can be depended upon to meet any national crisis. The great point is to bring them the real facts." With that very quote in mind, I am pleased to have the opportunity to return to the National Press Club to speak on an issue of critical importance to Australia's 4,000 clubs and all they represent. Their 10.5 million memberships, their 90,000 direct employees and the untold thousands employed downstream in associated industries, their 100,000 volunteers, and the hundreds of communities who rely on them. And let's not forget the five million people who play poker machines each year. In doing so, despite having been accused by prohibitionists in recent times of spreading lies and deception, I'm here to tell you the truth.

This issue centres on a deal to keep the current Government in power made by the Prime Minister with a newly elected Tasmanian independent who received 21.26% of the vote in his electorate last August. That deal makes it compulsory for the five million Australians who wish to exercise their legal right to play a poker machine each year, to possess what we describe as "a licence to gamble" - a card containing their personal details which would be linked to a national grid covering every single poker machine in every single venue across Australia. This would allow every bet placed by a poker machine player to be tracked by the Federal Government. "Big Brother" in the extreme, you might think.

With this intrusive device in place, players would be able to set binding limits on their expenditure, and if that limit were to be reached, they would be compulsorily prevented from playing a poker machine probably for 24 hours at any one of 5,700 clubs and pubs across the country, as well as casinos. The deal also provides for club and pub patrons to be prevented from withdrawing more than \$250 a day of their own money from an Automatic Teller Machine. Inexplicably, this does not apply to casinos.

Today, I want to explain to you why, in

our view, this nanny state proposal should not happen; why, in reality, it can't happen; and therefore what should happen.

First, a little background. Australia's 4,000 clubs cover a wide range of sporting, social, political and cultural pursuits embracing bodies such as RSL and Services clubs, football, bowling, golf, workers, Labor and Catholic clubs. Many have poker machines, with half of them in NSW where they have been legal since 1956.

On 23 June last year, the Australian Government released a Productivity Commission report said to be into gambling in Australia, but which, in reality, concentrated largely on poker machines. The report recommended that each state and territory should implement a jurisdictionally based full pre-commitment system for gaming machines by 2016, subject to initial development, trialling and compatible monitoring systems. It said the Australian Government should enter into negotiations with a state or territory government to sponsor a full-scale regional trial or trials of a full precommitment regime, with trialling to commence by 2013. Importantly, it said such a trial should substantiate that full pre-commitment has sufficient advantages over partial pre-commitment to justify proceeding with its implementation in all jurisdictions.

That same day, Federal Ministers Macklin, Sherry and Conroy issued a joint media release responding to the Productivity Commission report. They said it was necessary for the costs and benefits of any measures to be determined and that they would talk to the industry before anything happened. The Government rejected a ridiculous Productivity Commission recommendation that online gambling should be liberalised.

Also that same day, ClubsAustralia issued a statement to our member clubs and the media supporting the Government response and saying it was a victory for common sense, recognising that there is no silver bullet to problem gambling. On August 5, the Labor Party national

campaign headquarters gave a written undertaking to ClubsAustralia on the party's position leading into the election and, in good faith, we made this undertaking available to our clubs and their members before the election.

On the hustings during the election campaign, not one public policy announcement was made on this issue by Labor - or the Liberal-National Coalition. Not one single recorded doorstop quote to the media that I can find. Not a squeak. You all know the election resulted in a hung Parliament, with the Greens and four independents deciding who would hold power. So things changed.

On September 2, without consultation with the industry - or, I suspect, the vast majority of her own colleagues - the Prime Minister announced she had made a deal with the newly elected independent Member for Denison in Tasmania in return for his support in helping her form a minority government. That deal provided for a full mandatory pre-commitment scheme for poker machines that is uniform across all states and territories and machines. starting in 2012 and fully rolled out by 2014. It also provided for a \$250 daily withdrawal limit for ATMs in venues with poker machines - excluding casinos.

If Australia's state and territory governments did not co-operate with the introduction of this system, the Prime Minister agreed with the Member for Denison that she would seek to use Commonwealth powers to override them, and has been advised by the Solicitor General that she does possess those powers. If this was to happen, there is every likelihood that the Commonwealth would have to use taxpayer dollars to compensate the states and territories.

So we come to the present day and the ClubsAustralia assertion why this should not happen. There are three overriding reasons why this should not happen:

- We, and many others, say it will do little, if anything, to assist problem gamblers.
- Its implementation cost will drive clubs to the wall, resulting in their closure and the loss of thousands of jobs.
- Longer term, the loss of revenue as recreational gamblers walk away from our clubs in the face of this "licence to gamble" scenario will be equally devastating.

The Australian Government has seen plenty of evidence, only in the last couple of months, that this is a flawed proposal as far as helping problem gamblers is concerned.

Australia's leading academic on problem gambling, Professor Alex Blaszczynski, advised a Parliamentary Committee chaired by the Member for Denison that pre-commitment is unlikely to have a significant impact on the majority of problem gamblers, and may even exacerbate problem gambling. And common sense tells you he's right, because:

- Problem gamblers are unlikely to set affordable limits and are likely to set high limits or none at all.
- Problem gamblers are likely to take part in other forms of gambling that don't have pre-commitment limits, such as the TAB or online.
- There would be development of a black market for pre-commitment cards.
- Proper research needs to be done before spending vast amounts of money on an unproven technology.
- Overall, there has been no cost benefit analysis of mandatory precommitment.

And with regard to the absence of costbenefit analysis, isn't this an amazing way to make public policy on the run announce a wide-ranging measure impacting on millions of people, and only after that perhaps look to see what it might cost.

Reinforcing the ClubsAustralia stance, there is only one jurisdiction in the world that has mandatory pre-commitment and that's Norway, until recently often quoted by the anti-gambling lobby as evidence supporting mandatory precommitment. There are more poker machines in Crown Casino than currently in Norway and the Norwegian Government owns them all. In 2007 it decided to withdraw every poker machine for a year, with the aim of returning machines with quite modest compulsory daily, and monthly precommitment limits set by the Government, not by the individual player. Guess what happened in that year when there was not a poker machine in sight? Problem gambling in Norway did not decrease one iota as players simply migrated to other forms of gambling, particularly the internet. So, if you take anything out of Norway, take that. At a round-table discussion in Canberra before the final Productivity Commission report was released, a Commissioner made it clear in response to a question that they set out to "inconvenience" those who play poker machines. The Member for Denison is on the record as saying he'd like to see poker machines disappear altogether. But he

admits that his "restrictions" - his word - are a good step along the way to this ultimate extremist and prohibitionist goal.

Even if you do remove all the machines, the message from Norway is quite clear prohibition doesn't work.

As the President of ClubsAustralia I travel around the country and I talk to a lot of people far and wide, including those I know well in my own home city and state. And while I'm the first to admit this is not a "scientific" approach, the response I get when I talk to people about a compulsory pre-commitment system where they will need a card containing their personal details, linked to some national system connected to every other machine and venue in the country - it is anathema to them.

These recreational gamblers won't touch it with a barge pole. They will walk away, which of course is just what the prohibitionists want. When they walk, club revenues will crash, and clubs themselves will inevitably follow. The proponent of this deal has said himself the revenue impact would be up to 40%. He's right. There has been research in Nova Scotia and South Australia that supports this. And we also know our punters.

But let's just suppose the downturn is 30%; that's bad enough. A KPMG study shows that in NSW alone a 30% revenue downturn for clubs would result in the loss of more than 11,500 jobs, a loss of \$820 million from the NSW economy, and force the closure of clubs. Extrapolated nationally, with pubs and casinos included, the damaging impact would reverberate across the whole economy. This out-of-left-field deal which blindsided the industry has left thousands of club and pub employees anxious and concerned for their future. Economic purists may pontificate from on-high that lost jobs will be picked up and replicated elsewhere in the economy. Try telling that to a young mother pulling a beer in Gilgandra, a university student clearing tables in Ballarat, a man on the door in Ipswich. A young bloke who works at my club in Wollongong asked me the other night where this was all heading as he has a small child, his wife is expecting another, and he fears for his job. I told him that if necessary we were committed to going all the way in one hell of a fight, but I could give him no guarantees. He said to me: "Mate, if this happens I'll never vote for those people again."

Added to all of this, and notwithstanding

the Prime Minister's legal advice, Australia's states and territories have enormous concerns about mandatory pre-commitment and ATM limits on what people can withdraw of their own money. The current NSW Labor Government believes it is absurd to try and introduce this without a cost-benefit analysis or any sort of trial. The NSW Liberal-National Coalition will not support mandatory pre-commitment if it comes to power, but says it will favour a system that is voluntary for the player, venue-based and affordable.

The Victorian Government says it will refuse to have its state's intended harm minimisation measures overridden by the Commonwealth. And that means voluntary pre-commitment, not mandatory. South Australia is on the record against mandatory precommitment. So the Commonwealth has a fight not only with industry, but with states and territories as well. And all of this is happening at a time when states and territories across the country have been reporting year-on-year a marked decline in the prevalence of problem gambling.

The anti-gambling lobby claims the states and territories and the industry give only token attention to the issue of problem gambling. This is not true. In NSW, which hosts half the poker machines in the country, problem gambling rates halved from 0.8% of the adult population in 2006 to 0.4% in 2008. Calls to G-Line, the Government's wellpromoted telephone help line for gamblers, have halved in the past decade. The Queensland Government has conducted four surveys, each of some 30,000 respondents over seven years from 2001, and found a consistent decline from 0.83% to 0.37%.

So that's why it shouldn't happen.

Why can't it happen?

I am sure that when they reached this agreement, neither the Prime Minister nor the Member for Denison had the first idea of what was involved, of the size and complexity of the animal they had grabbed by the tail.

Let me give you a few basic statistics. There are around 198,000 poker machines in 5,700 venues spread across Australia. There are a dozen different manufacturers and these machines operate on eight different state or territory-approved systems which do not "talk" to each other. The best estimates of the time it would take to develop and integrate the technology and roll it out across Australia is 14 years. The Australian Government has received expert advice that to equip all the machines with the technological capacity to accommodate a universal Australia-wide mandatory precommitment regime, a quarter of them may be able to have a suitable software update. One guarter would need a hardware and a software upgrade, and half the total number of machines about 99,000, would need to be replaced at a total cost of around \$3 billion. There would need to be a national network linking all states and territories and a database capable of tracking every player's activity. Some in the anti-gambling lobby propose the database be managed by the Australian Taxation Office or Centrelink. The technical experts say no solution

the enormous complexity involved. As the biggest gaming machine manufacturer in the world has noted: "The complexity and the permutations of this development work and its deployment is extraordinary and would take an extended period to complete, recognising that the market itself has evolved to its present state of complexity over an extended period." In the case of NSW, of course, this period extends back more than half a century.

would be cheap, easy nor quick due to

To give you an example of the comparative complexity, this "licence to gamble" system would be twice as big as Telstra's broadband system. So we're talking about a big, complex animal here that I am sure those who made this political deal do not understand. Indeed, even the Member for Denison remarked during one of his committee hearings that there's a vast difference between political deals and technical reality. Technical challenges aside, we're also talking about a cost to clubs and the industry of billions of dollars - all supposed to be expended in a compressed timeframe expiring in 2014. That is simply not possible - a 2014 deadline beginning next year is not technically or financially possible. Clubs and pubs would go bust in the process. And all just to keep one MP onside - an MP who received fewer votes than many clubs have members.

So, what should happen?

ClubsAustralia has always been in favour of targeted, sensible, effective and affordable measures to further reduce problem gambling. On October 22, 2008, I stood on this same podium and on behalf of ClubsAustralia presented a sixpoint plan to further help reduce the incidence of problem gambling. It included suggestions covering family interventions, education, greater empowerment of counsellors and improved counselling services, proper research and ensuring that measures are not experimental, venue staff training, tightening regulation of the internet and a ban on betting on credit.

On that occasion the anti-gambling lobby could hardly wait for me to conclude speaking before running to the media and describing what I had put forward as a "joke". But that's what we expect from prohibitionists. We have not been discouraged by that and continue on. We are driving trials of voluntary precommitment, and investing heavily in a multi-venue self-exclusion scheme. The unfortunate consequences of this obsession with mandatory precommitment is that such other measures that would further assist problem gamblers are not receiving the attention and support they deserve.

Let me make it clear with regard to this specific matter I am addressing today, ClubsAustralia is not against precommitment as such. We would support a system that is voluntary for the player to use, is venue-based and is affordable. We have offered to proceed down this path with government. Indeed, some clubs already are offering their members the choice of setting a limit voluntarily if they feel it will help them.

We will not agree to a compulsory system that is personally intrusive, deliberately designed to

"inconvenience" players, and which will be a turn-off to most ordinary, everyday Australians who wish to spend some of their recreational and entertainment time playing poker machines.

And in taking this stance, we also ask: What further intrusions can Australians expect? What's next?

The Australian Government should deal meaningfully with industry and not simply shove a politically expedient done deal in our faces. In other words, it should stick to its pre-election promise. The Prime Minister has until around May next year to introduce legislation into Parliament on this issue. Should she elect to do so, the 148 MPs sitting in the House of Representatives will have a clear choice. They will need to decide whether to vote for, or against, a compulsory system that is disastrously expensive, personally intrusive, deliberately designed to

"inconvenience" players, and which will be a turn-off to most ordinary, everyday Australians who wish to spend some of their recreational and entertainment time playing poker machines, while doing nothing to assist problem gamblers. Millions will have an interest in the public position of these MPs. And, while contemplating their vote, they should acknowledge the real

they should acknowledge the real "elephant in the room". That woolly mammoth of course is the internet and its lure to vulnerable people who sit at home, often alone with no social inclusion, and have the choice of 2,000 sites on which they can gamble on credit, many with money they do not have.

According to Merrill Lynch, Australians spent \$840 million on online casinos and poker in 2008, with the bulk of this spent on online slots and table games. This burgeoning industry is powering on with no taxes being returned to Government, very few jobs, and no regulation.

If you'd like some examples, I invite you to Google "online gambling". You'll discover sites such as "online pokies.com.au" and

"allslotscasino.com.au". You'll be able to read that there are "proven strategies" that ensure you'll win 99% of the time you play the cyber pokies ... advising that the best way to win on the pokies is to gamble online ... inducements involving "free dollars" and

300% deposit bonuses, and the like ... claims that site providers have "inside information" on how poker machines work. You will also discover an online chat window with a live operator on the other end offering bonuses and assuring you that playing online slots will "boost your bankroll".

And this all going on while the

Government and the Member for Denison want to demonise clubs and pubs who do not offer gambling on credit... whose venue ATMs cannot dispense cash on credit ... who cannot offer such inducements ... and who subscribe to world's best-practice harm-minimisation measures.

So, for the various reasons I have outlined - why this deal should not be enforced, why it cannot be enforced, and what should occur, I can confirm that ClubsAustralia and the Australian Hotels Association, representing clubs and pubs across the nation, will undertake a public campaign to raise awareness of this issue and all that it represents. Our campaign will inform our millions of members and patrons, our hundreds of thousands of employees, the five million people who play the pokies each year, our 100,000 volunteers, the many sports and charities we support every day of the week, and the people of Australia generally.

We will also continue impressing upon legislators just what this ill-conceived, untested, uncosted, un-Australian deal means. I, for one, am not prepared to see our magnificent Club Industry destroyed on an altar of political expediency - and I have no doubt an enormous number of my fellow Australians will feel the same way, let alone the prospect of having government breathing more heavily down our necks. Perhaps those who would sit in judgement of us at a Federal level would do well to heed the words of Oueensland Premier Anna Bligh after her state's horrific floods this year. Referring to the devastated Goodna Leagues Club, between Ipswich and Brisbane, and saying it should be the first place in the state to be rebuilt under the Sunrise program's Operation Bounceback, she said: "This club is the absolute heart of the community. It is the one place they have where their children and their community members play football. It is the only place they can go and have community meetings, where they have community events, 21st birthdays, those sorts of things. It really is the community centre of this suburb." So the Oueensland floods may have done their worst, but they will not destroy Goodna Leagues Club. Only the Member for Denison at the other end of the country, with a gun to the head of the Australian Government, can do that. Today, I am declaring that for the reasons outlined, clubs and pubs oppose mandatory pre-commitment, as well as government-imposed restrictions on how Australians can access their own money.

Victoria's new Gaming Minister draws state

Victoria's new Gaming, Consumer Affairs and Energy Minister MICHAEL O'BRIEN has wasted no time in declaring his hand on critical policy issues affecting the Club Industry and in his first interview with *CMA Magazine* correspondent KATIE CINCOTTA, Mr O'Brien candidly states that the Federal Government's controversial push for compulsory pre-commitment on gaming machines as a Big Brother nanny state policy. While he supports pre-commitment as a problem gambling strategy, Mr O'Brien insists the spending limits should be optional ...

In November 2010, Victoria elected its first Liberal Government in 11 years,

declaring former architect and daily swimmer Ted Baillieu the new Premier. Michael O'Brien, a former barrister with two young children, was appointed the new Minister for Gaming, Consumer Affairs and Energy, after serving as the Shadow Minister for Gaming since 2006.

As an experienced advocate, the young Minister from blue-ribbon Malvern has wasted no time in declaring his hand on critical policy issues affecting the Club Industry, including the controversial push for compulsory pre-commitment.

Mr O'Brien has described mandatory pre-commitment on pokies as a "Big Brother nanny state policy".

While he supports pre-commitment as a measure to address problem gambling, Mr O'Brien insists the

spending limits should be optional.

"The Victorian Government's position - clearly set out in our election policy - is that individual customers should have the right to choose whether or not to use the precommitment technology.

"Our aim is to offer support to people who seek assistance to control their gambling, without unduly interfering with the rights of individuals who may not wish to provide personal information in order to play a gaming machine," he told *CMA Magazine*.

With the Federal Government making a legal push for mandatory precommitment, threatening to use its constitutional powers to legislate on electronic gaming machines across the nation, the once self-employed barrister in trade practices and commercial law is using his legal mettle to push back.

"The regulation of gambling always has been - and should remain - a matter for the states," Mr O'Brien said.

"It would be inappropriate for the Federal Government to seek to prevent the Victorian Government from delivering our election commitments on pre-commitment.

"We will seek advice on any attempt by the Federal Government to do so."

The Minister told *ABC News* that the Gillard Government was making

Old guard playing 'hard ball' with clubs

As Victoria's gaming duopoly ready themselves to step aside, how will the Government help manage the transition and protect clubs from bullying by Tattersalls and Tabcorp?

TGS (Tabcorp Gaming Solutions) has twice been investigated by the consumer watchdog for threatening to take away machines if clubs didn't sign up to six-year deals.

Club managers under Tatts say the company is also playing "hard ball" and threatening to withdraw highperforming machines as per its contract.

Victoria's Gaming, Consumer Affairs and Energy Minister Michael O'Brien says the Government's policy is to work with industry to facilitate a smooth transition.

"The Government is engaging with stakeholders - the incumbent licensees and many venues - to provide greater certainty going forward," Mr O'Brien says.

"We are focused on the impact on the industry as it gets ready for 2012."

In the meantime, club managers such as Rick Scott, who heads up City Memorial Bowls Club in Warrnambool, are charging ahead with their strategy for owner-operated poker machines.

"We have gone with SGS [Specialised Gaming Services] headed by Scott Meyers who set up Tatts Pokies years ago in Victoria and South Africa, plus business development and corporate strategy with numerous companies," Mr Scott said.

"We've also engaged Glen Crawford who has had senior product roles both as a gaming and venue operator with Tatts and nationally with ALH.

"We are basically doing it ourselves with expert support and advice.

"This will give us control of our own destiny."

battlelines on pre-commitment

threats with "a dog's breakfast of constitutional provisions" to honour the deal with Tasmanian Independent MP Andrew Wilkie, which reeks of political power play rather than best policy outcomes.

"State governments understand the industry and the delivery of services to treat problem gambling," Mr O'Brien said.

"The Federal Government has demonstrated through programs such as the home insulation scheme that it is not the best level of government to deliver 'on-the-ground' services."

As the Club Industry moves closer to the ban on ATMs in gaming venues, the Minister declares the scheme fixed and non-negotiable.

"The Victorian Government will continue to implement the legislative ban on ATMs in gaming venues, which takes effect on July 1, 2012," he added. "This policy is aimed at reducing gambling-related harm."

Mr O'Brien acknowledges club concerns that venues could lose patrons because of the inability to withdraw cash, especially in an environment regarded as safer than a public ATM.

"The Victorian Government is aware of the concerns of clubs about the impact on their patrons, and will monitor and evaluate the impact of the ban on ATMs," he said.

Where the incoming Liberal Government did make swift change was in reducing liquor licensing fees to help ease the burden on businesses and community groups that pose a lower risk in relation to alcoholrelated violence.

"For more than 10,000 small businesses and community clubs right across Victoria it means liquor licensing fees will be more than halved," the Minister added.

The base renewal fee has been reduced for the following categories:

- Full club (without gaming machines)
- restricted club
- ▹ vignerons
- restaurant and cafe
- renewable limited and BYO permits.

"The previous Labor Government increased liquor licence fees across the board, hurting many community and sporting clubs," Mr O'Brien said.

"The Baillieu Government's changes recognise the important place of clubs in our community, and the lower risk they pose compared to some other types of licensed venues."

With clubs now making serious plans for the transition to owner-operated gaming in 2012, the Monitoring Licence still hangs in the balance.

In October 2010, four registrants were invited to apply for the 15-year, single independent monitoring licence -Intralot, Tabcorp Monitoring, Maxgaming Vic and Monverco.

The Minister says the Gambling Licences Review within the Department of Justice is currently assessing those applications and the VCGR is undertaking probity checks of the four contenders.

"As the project is still in what is called a 'competitive bidding' phase, it is not appropriate to make any further comment," he says.

RSL Club entry laws change proposed

The NSW Liberal and Nationals parties Coalition are proposing changes to the Registered Clubs Act to allow exservicemen and women automatic entry to RSL clubs throughout NSW. This policy is similar to initiatives in other states that allow Returned and Services League members to access RSL clubs with greater ease.

In Victoria, members of RSL clubs when visiting other RSL clubs, receive reciprocal member benefits without needing to sign in. NSW RSL members also are granted access to licensed RSL sub-branch clubs in Victoria. All 55,000 RSL members in NSW must sign in at each RSL club they visit. Under the proposed changes, full service members of the NSW Returned and Services League would not need to sign in when visiting one of the state's 270 RSL clubs. RSL members will be allowed access to a club after producing a valid financial RSL membership card. Full service members would still be required to be a member of at least one licensed RSL club, most likely a club close to their home which they visit regularly, to ensure the concept of club membership is retained.

Then-NSW Opposition Leader Barry O'Farrell and Shadow Minister for Hospitality, Tourism and Major Events George Souris announced the proposal in the lead-up to the NSW Election on March 26.

Mr Souris said a NSW Liberal-Nationals

Government would amend the Registered Clubs Act to allow exservicemen and women who are RSL members entry to RSL and kindred clubs on producing a valid financial membership card of the RSL.

NSW RSL State President Don Rowe and RSL and Services Clubs Association Chairman Bryn Miller welcomed the announcement which has been an Association long-term goal. "This is good news for our members who will be able to more easily access RSL and Services Clubs across NSW," Mr Rowe said. "I'm happy the NSW Liberals & Nationals took the time to listen to our concerns and act positively to help our members and their clubs."

GTA welcomes new Chairman, members

The Gaming Technologies Association has announced important governance and membership changes in the leadup to the 2011 Australasian Gaming Expo - G2E.

ClubsNSW Chairman Peter Newell, OAM, presented the ACE Lifetime Achievement Award to Mark Loyd, one of the most awarded and respected entertainers and producerdirectors to have worked in the Entertainment Industry in Australia. He is regarded as the professional's professional and has worked with the biggest and best performers to have taken the stage.



Mark's close friend Paul Martell, who picked up the award for "Best Comedy Act" at the 2010 awards gala at Canterbury Hurlstone Park RSL Club, had the pleasure of profiling the life and times of a remarkably successful career in the spotlight and behind the stage.

Paul, through Gregg Arthur's beautifully written biography, proudly conveyed the story of a young man recording hits at the height of the music revolution in London to producing show spectaculars across the United States, Europe, Asia and Australia.

Mark has been in the Entertainment Industry for 53 years. His first paid gig was as a singer/drummer in 1958.

> In those exciting times in London, Mark was already making a name on live gigs and with studio sessions, working solo and with a popular group, The Monotones.

It was in the '60s that Mark became a session musician at EMI's Abbey Road studio. A record contract with Parlophone followed and a hit record, "Everybody Tries", in 1965 went to No.4 in the charts. He had a hit in Germany and Holland with "Judy in Disguise" that sold 110,000 copies in the first week of its release. Mark also had success in the UK and America with The Treetops.

Mark first came to Australia for just a few weeks as an "import" act in 1977. After fulfilling contracts in England, he came back in 1979 and made Sydney his home. Mark's first act in Australia was "Mark Loyd and Vanity Fair".

In 1985 he met his wife Debbie Graham, one of Australia's leading choreographers, and they produced the act, "Mark Loyd With Pleasure", and formed their production company, "Popset". The act became one of the most successful shows in Australia and overseas, touring major hotel circuits in Malaysia, Singapore, Thailand, Indonesia, Borneo and Scandinavia. In 1990, Mark revamped his show as "Licensed to Thrill", becoming an instant hit.

Mark's shows have won 11 Mo Awards, while he produced and directed three Mo Awards and three ACE Awards. His direction skills have been seen in Australia, Asia, England, Scandinavia, South Africa, Brazil and Las Vegas where he directed "The Grand Cirque" at the Desert Inn. He also performed at the Rio, Stardust Hilton Convention Centre and the Desert Inn.

After a long and successful stage career, Mark concentrated on producing and directing. In 1999 he performed his last shows at Souths Juniors, filling the auditorium for five weeks and 13 shows.

Following the Trade Show and Dinner on Tuesday, March 8, Phil welcomed 35 members, including four new members and Association Executive Officer Terry Condon to the CMAA Zone Meeting at 9 o'clock on Wednesday morning. The new members are Paul Clarke - Walgett RSL Club, Mitchell Reece - Armidale Ex-Services Club, Jeff Benson - Moree Golf Club and Nathan Chapman -Armidale Golf Club.

In his Head Officer Report, Terry praised the Zone Committee and members for their genuine passion for the Club Industry and their support of events across the Zone. Terry engaged the members in strong debate about the Federal Government's planned legislation for mandatory pre-commitment technology being installed on all gaming machines around Australia and referenced the Club Industry's joint submission to the Parliamentary

Committee investigating the controversial subject. Following on from CCM Travel Managing Director Catherine Mancuso's article in the February edition of CMA Magazine, Terry spoke about the importance of members having appropriate travel insurance cover. He also commented on the success and positive feedback from the Zone's Corporate Governance workshop with Dr Michael Singleton. Terry spoke about Federal Secretary Allan Peter's enhanced role with the CMAA and that the Association had advertised his Executive Officer role as he will retire in August. In closing his report, that also featured Barrington's upgrade Armed Robbery Online Induction program and the Association's CMA CARE welfare program, Terry congratulated Phil Wheaton on being inducted into the CMAA Hall of Fame.

In his President's Report, Phil Wheaton reported on the Zone's Corporate Governance Program with Dr Michael Singleton on February 19 at Inverell RSM Club where 18 clubs and 58 representatives from those clubs attended.

In his Education Officer's Report, Patrick Crick discussed education and professional development training options over the next two years and the possibility of those programs including club directors who have shown strong interest in the Association's training opportunities. Patrick alerted members to fact the Zone had contracted to stage a fullday Information Technology Summit at Quirindi RSL Club in May, with the summit fully funded from the Zone's education funds.

Reward scheme advertising around gaming machines ... what's the law?

Unlawful - Many venues promote their member reward schemes via their websites. However venues cannot include references to gaming or gaming machines in such advertising. It is prohibited under NSW gaming laws.

Lawful - Material that promotes member reward schemes can include

reference to gaming machines - if it has been sent directly to the member and he/she has given prior consent to receiving promotional material that refers to gaming machines. Internal promotional material about member reward schemes, available from within the venue, can lawfully refer to gaming machines. In General Business, Phil briefed members on the meeting with Federal Independent MP Tony Windsor when a select group of club managers met to discuss the Gillard Government's alliance with Tasmanian Independent MP Andrew Wilkie to introduce mandatory precommitment technology on all gaming machines. Phil said Mr Windsor appeared very supportive and confirmed that before he makes any decisions he will look at what effects the legislation may have on his electorate that encompasses 77 clubs. Mr Windsor was made aware of the massive installation costs and the 40% reduction in revenue. Phil said the meeting's overwhelming message to Mr Windsor was that precommitment does not solve problem gambling.

North West State Zone's next event will be a Zone Meeting and Dinner at Lightning Ridge Bowling Club on August 9-10 with the Christmas Dinner and Meeting at Wests Leagues Club, Tamworth, on December 6-7.

Know when to say when

NSW Health has launched a state-wide advertising campaign looking at changing attitudes and habits towards drinking alcohol and drinking to excess. The campaign contrasts the difference between having a good time with a few drinks and how that can change if too much alcohol is consumed with the main message -"Know When To Say When". This campaign isn't about preventing people from having a drink and enjoying themselves, but for people to consider the way they drink. The campaign is appearing on television, in magazines and on radio in NSW. Venue operaters can promote the campaign by downloading and displaying the "Know When To Say When" poster.

Food Safety Supervisor

The NSW Food Authority has announced the start of the Food Safety Supervisor (FSS) scheme for food businesses in NSW. The FSS scheme requires certain food businesses in the hospitality sector, including clubs, to appoint at least one trained FSS. Clubs have until October 1, 2011 to comply with the scheme. The CMDA is offering two more FFS Courses in the first half of this year ...

- Course 2 Tuesday, April 19
- Course 3 Tuesday, May 31

The courses will be presented at the CMAA's Head Office -Level 2 RAS Building, 1 Showground Road, Sydney Olympic Park. Homebush Bay. Candidates can register online at www.cmaa.asn.au. If a FSS leaves, the club must appoint a new FSS within 30 days of the existing FSS leaving. Clubs will have an additional seven days to notify their local council of the new FSS. Staff members who have completed the two FSS courses since January 1, 2007, will have their training recognised. In these cases, clubs should contact the NSW Food Authority to arrange for an official FSS Certificate (cost \$30) to be sent to the club. Only training offered by NSW Food Authorityapproved training providers - including the CMDA - will be recognised by the Government for the purposes of the FSS Scheme.

Carbon tax will hit food

The cost of everyday staples will rise and shoppers will increasingly turn to imported foods if Australia's food manufacturing industry is not protected from overseas pressure under a carbon tax, experts have warned. Responding to the Gillard Government's announcement that Australia will have a price on carbon by July next year, the Australian Food and Grocery Council said Labor must take into account the future competitiveness of the food industry. Prime Minister Julia Gillard's plans mean Australia will move from a fixed price on carbon to a free trading emissions scheme within three to five years. The Council's CEO Kate Carnell said Labor indicating the agriculture industry would be exempt from a carbon tax, transport, fuel and power costs would still make an impact on the sector. Food and grocery is Australia's largest manufacturing sector, worth more than \$102 billion annually. It accounts for 9% of Australia's international trade. But pressures from years of drought and rising manufacturing costs had contributed to an increase in food and grocery imports of more than 40% over five years. A recent report from the think tank, The Climate Institute, found extreme weather events caused by climate change were a far greater threat to food prices than an emissions trading scheme (ETS), which is expected to be about \$1.30 or 1% a week. Politicians of all persuasions have invested time selling or slamming the proposed carbon tax.

Gatton RSL Club boss Les Nash is no stranger to natural disasters. He's been in the thick of many floods and cyclones during 25 years with the Australian Army in northern Australia, including Cyclone Tracy in 1974.

"I was with the emergency teams involved in clean-up operations in Darwin," Les recalled. "We were there for about seven or eight weeks."

But none of that prepared him for the enormity of the most recent events.

"The damage in the Lockyer Valley and Toowoomba was unbelievable," he said.

Les's latest encounter with nature's fury also has a strong personal element.

His son Ben, who works at the Tully Leagues Club, was to have been married to long-time fiancée Michelle at Mission Beach on Saturday, February 5.

Cyclone Yasi intervened.

The Tully-Mission Beach area is where it made landfall on the previous Wednesday at midnight, with devastating force.

The club suffered major damage. The reception area at Mission Beach was flattened by Yasi's ferocity.

"The wedding has been postponed until things get back to normal," Les said with a rueful smile.

Back at Gatton, the town and the club had survived the deadly floods

that devastated parts of the Lockyer Valley and Les was heavily involved in ferrying emergency supplies to stranded residents in stricken areas.

The Gatton RSL Club also became the catering facility for emergency crews working in the Lockyer Valley area.

"It was just cut lunch type of stuff, but it was much appreciated," Les said.

Les began his career in the Licensed Club Industry in the late 1990s when he took on the manager's job of what was then the Tully RSL Club.

He quickly recognised the value of CMAA membership and became North Queensland Zone Education Officer a post he held for more than five years before moving south to Gatton in 2002.

He took a break from Gatton in 2006 for a posting with the Wynnum-Manly clubs group in Brisbane for about 18 months, then answered a call to return to his former job at the Gatton RSL Club.

Natural disasters aside, Les is happy to be back.

His club is an attractive little entity, strategically placed on the fringe of the Gatton CDB, near the railway station.

Importantly, it occupies its own freehold land.

It may be small in floor space, but it has a pleasant atmosphere with modern décor and a membership of just over 5000 - not bad in a town with a population of less than 10,000.

Les Nash is now looking to a future with a long commitment to Gatton, to his club, and to the nearby community that's struggling to recover from the worst disaster in its history.




